Spill Control Survey	Evaluate the current spill control program and provide recommendations for spill products based on location and type of spill. Additionally, suggest appropriate absorbents for water-based, oil, and chemical liquids.
Arc Flash Compliance and Awareness Assessment	Conduct a review of the existing arc flash program, training, labeling, and provide an overview of arc flash regulations and best practices.
PPE Assessment	By implementing a 5-step program, including PPE assessment and application-specific training, we ensure that employees are equipped with the suitable Personal Protective Equipment, thereby enhancing their overall safety.
Predictive Maintenance Seminar	Provide an overview of acoustic and thermal imaging, vibration analysis, insulation resistance testing, and process calibration, along with general best practices.
